## LIMITED WARRANTY

Warranty is applicable to the following models, when installed as an AHRI matched system:

- BVA-24WN1-M18
- BVA-36WN1-M18
- BVA-48WN1-M18
- BVA-60WN1-M18

Bosch warrants this product against failure due to defect in materials or workmanship under normal use and maintenance as follows. The warranty period begins on the date of original purchase from wholesaler/supplier, or manufacture date plus 180 days, whichever comes first. If a part fails due to defect during the applicable warranty period, the distributor will provide a new or remanufactured part, at the option of the distributor, to replace the defective part at no charge for the part. This limited warranty is subject to all provisions, conditions, limitations and exclusions listed below.

- 1. A warranty of Five (5) years on all parts to the original end user.
- Limited warranty applies only to systems that are properly installed by a state certified or licensed HVAC contractor, according to local, state and federal law in accordance with all applicable building codes and permits. EcoTemp installation and operation instructions and good trade practices must be followed.
- 3. The system is installed in a residential application.
- 4. A replacement Outdoor unit will be provided if the compressor is confirmed defective during the first (1) year of installation, if it fails during the warranty period. Unit replacement must be authorized by the distributor prior to replacement.
- 5. A replacement Outdoor unit will be provided if the outdoor refrigerant coil is confirmed as having a non-repairable leak in the "fin" area, during the first five (5) years of installation, if it fails during the warranty period. Unit replacement must be authorized by the distributor prior to replacement.
- 6. Warranty applies only to products remaining in their original installation location.
- 7. Defective parts must be returned to the distributor by a state certified or licensed servicing dealer for credit.
- 8. Utilization of non-approved parts or accessories will void all warranty.
