

LIMITED WARRANTY

Bosch Air 500, Air 1000, Air 2000, Air 4000 & Air 6000 Air Purifiers

MODELS COVERED

This limited warranty is provided by Bosch Thermotechnology Corp. ("Bosch") and covers the Bosch Air 500, Air 1000, Air 2000, Air 4000 & Air 6000 Air Purifiers (hereinafter referred to as "Product"). This warranty is provided to the original purchaser of the Product.

WARRANTY COVERAGE

Limited Warranty – Residential

Bosch warrants that the Product will remain free from defects in material and workmanship three (3) years from the date of purchase and the other conditions of this warranty are met. For California residents, the effective date of this limited warranty will commence no sooner than the delivery date to the consumer. If Bosch determines that the Product has a defect in workmanship or materials, Bosch, at its option, will replace the Product. This warranty is only valid for the first person who purchases the products from authorized sellers. It cannot be transferred to anyone else, even if the product is sold during the warranty period.

ITEMS NOT COVERED

This limited warranty does not cover the following circumstances:

1. Components or parts not provided by Bosch.
2. Product not installed, used and maintained as per the instructions in the user manual.
3. Components or parts, on which the tags or nameplates have been removed, altered or defaced.
4. Scratches in or discoloration of finishes.
5. Bosch disclaims and does not assume any liability of any nature for unsatisfactory performance caused by improper installation, repair or maintenance.
6. Any labor or material costs for removal, reinstallation, repair and replacement of the defective component or part unless otherwise provided above.
7. Electricity or fuel costs, or any increases or unrealized savings in same, for any reason whatsoever.
8. Damage caused by operation of the Product in a corrosive atmosphere, electrical failures, flooding or acts of God.
9. Damage caused by any attachment or modification to the Product, including any energy saving device.
10. Shipping charges, delivery expenses or administrative fees incurred by the purchaser in repairing or replacing the Product.
11. Expedited shipping charges, delivery expenses or administrative fees incurred by the purchaser in repairing or replacing the Product.
12. This warranty does not cover Pre-Filter or the HEPA filters, except for material or workmanship defects.
13. Damage caused when the product is used for a purpose that is not its intended purpose.

LIMITED WARRANTY

ANY IMPLIED WARRANTIES FOR A PRODUCT SHALL BE LIMITED IN DURATION TO A PERIOD OF THREE YEARS FROM THE DATE OF PURCHASE. BOSCH'S SOLE OBLIGATION WITH RESPECT TO THE PRODUCT AND PURCHASER'S EXCLUSIVE REMEDIES ARE SET FORTH IN THE FOREGOING LIMITED WARRANTY. BOSCH SHALL NOT BE LIABLE FOR ANY INDIRECT, PUNITIVE, INCIDENTAL, SPECIAL, CONSEQUENTIAL OR SIMILAR DAMAGES INCLUDING, WITHOUT LIMITATION, INJURY OR DAMAGE TO PERSONS OR PROPERTY OR DAMAGES FOR LOSS OF USE, LOST PROFITS, INCONVENIENCE OR LOSS OF TIME. NOTE THAT ANY REPAIRED OR REPLACED PRODUCT WILL BE WARRANTED FOR ONLY THE UNEXPIRED TERM OF THE ORIGINAL WARRANTY.

Some states and Canadian provinces do not allow the exclusion of limitation of damages, or limitations on how long an implied warranty lasts, so the above limitations and exclusions may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which vary from State to State in the U.S. and from Province to Province in Canada.

WARRANTY CLAIMS PROCESS

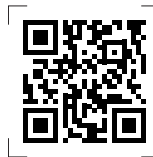
To make a claim under this Limited Warranty, you must contact Bosch Customer Service at airpurifier.support@us.bosch.com or +1-800-283-3787. To process your claim, you will need a copy of your original invoice or other proof of purchase. The alleged defective Product must be returned to Bosch in accordance with Bosch procedure then in force for handling goods returned for the purpose of inspection to determine cause of failure (contact Bosch if you have questions regarding the return process). If Bosch determines that the returned product is defective and that this warranty applies, Bosch will replace the Product.

THIS WARRANTY APPLIES TO PRODUCTS PURCHASED, DELIVERED AND USED WITHIN THE FIFTY STATES OF THE UNITED STATES, CANADA, THE DISTRICT OF COLUMBIA, AND PUERTO RICO.
